ENTRIES CLOSE April 13, 2018 at 5 PM.

- A separate form must be submitted for each dog entered.
- Entries not on Official AKC entry forms or photocopies without the agreement and rules are unacceptable.
- Entries will not be accepted without fees.
- No refund for duplicate entries or for any other cause beyond the control of PBCA will be made after the closing date.
- Owners are responsible for errors in making out entry forms (whomever may make such errors) and no entry fee will be refunded in the event of such errors or cancellation of entries after the closing date. Changes, additions, or corrections to the entry form must be received in writing prior to the closing date.
- Returned checks do not constitute a valid entry. The treasurer will add a \$20 collection fee to the amount of each returned check. All fees must be submitted in US funds.
- After the closing date, no entries can be accepted, cancelled, altered or substituted.
- Entry fees shall not be refunded in the event the dog is absent, not allowed to compete in the entered class, disqualified, excused by a veterinarian or judge, or barred from competition by action of the Trial Committee. If because of riots, civil disturbances, or other acts beyond the control of PBCA it is impossible to open or complete the Test/Trial classes, no refund will be made.
- PBCA may decline entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other cause and no one shall have claim or recourse against PBCA or any official thereof.
- Please clean up after your dog at the site and hotel.

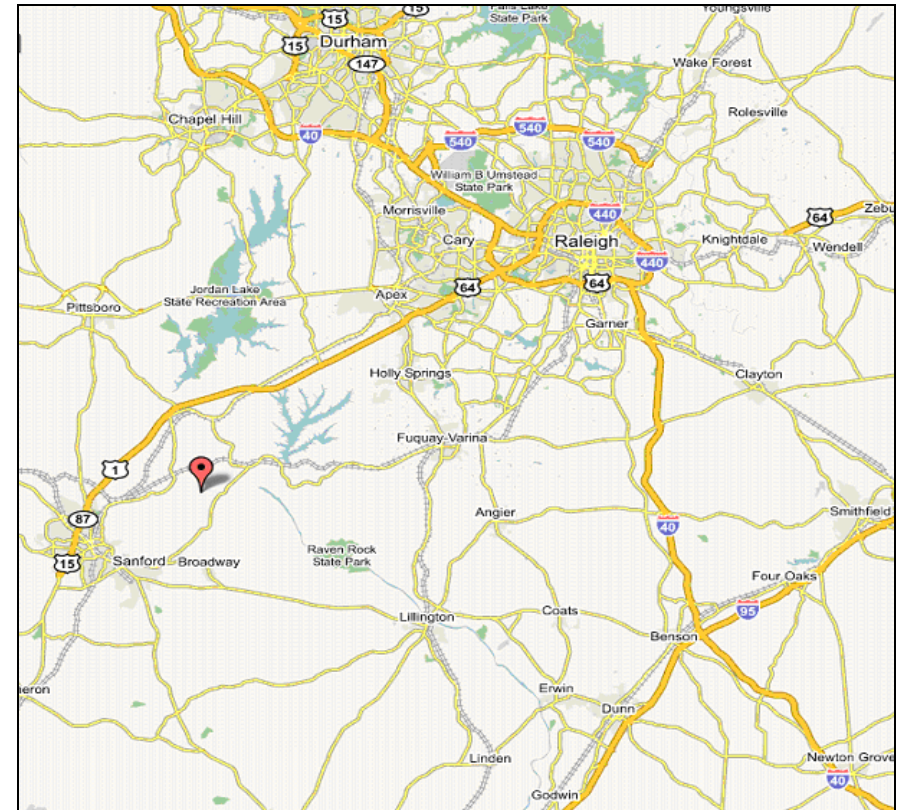

DIRECTIONS TO WAY TO ME FARM

From Raleigh and north, take US 1 S to Pea Ridge Rd. Turn left from exit ramp and continue on Pea Ridge Rd for 1.4 miles to intersection with Old US 1. Turn left onto Old US 1 and continue 0.2 miles to Corinth Rd. Turn right onto Corinth Rd and continue for 5 miles to the intersection with NC 42. Turn right onto NC 42 and continue 2.6 miles to intersection with Poplar Spring Church Rd. Turn right and continue about 1.5 to drive for trial site on left. Follow drive to the end.

From Southern Pines and south, take US 1 N to intersection with Tramway Rd (NC 78). (This is about 1 mile south of Palomino Hotel.) Turn right onto Tramway Rd and continue for 4.5 miles (Tramway Rd becomes Main St) to the intersection of Horner Blvd (US 421). Go straight through the intersection (Main St becomes NC 42) and continue on NC 42 for 9.2 miles to intersection with Poplar Spring Rd. Turn left and continue about 1.5 to drive for trial site on left. Follow drive to the end.

Follow signs at the farm for parking. Do not park in areas not designated for parking.

AGREEMENT

I (we) acknowledge that the "Rules Applying to Registration and Discipline" and the "Regulations for Herding Tests & Trials" have been made available to me (us), and that I (we) agree that the club holding this Herding Test or Trial has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the Herding Test or Trial and of the opportunity to have the dog tested or judged and to win ribbons, or trophies, I (we) agree to hold this club, its members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the Herding Test or Trial premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be abused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other causes.
